## Prepaid Credit Card Terms of Service

### 1. Agreement Overview

These Terms of Service ("Terms") govern your use of any prepaid credit card product ("Card") issued through Strike Force Agency LLC ("Company", "we", or "us"). By activating or using the Card, you agree to these Terms and any related policies provided by the issuing bank or processor.

### 2. Card Issuance & Ownership

- All Cards are issued by our licensed financial institution partners.
- Cards remain the property of the issuer and must be returned upon request.
- Cardholders must be 18 years of age or older and reside in the United States.

### 3. Card Use

- Cards may be used for purchases wherever Visa/Mastercard (depending on card type) is accepted.
- No credit or overdraft feature is available.
- We may set spending or loading limits based on risk, verification, or regulatory requirements.

- Funds typically settle within 1–3 business days.
- Reload fees, if applicable, will be disclosed prior to loading.

- Fraud, misuse, or suspicious activity
- Regulatory concerns or failure to meet eligibility criteria
- Breach of any terms outlined herein

## 10. No Warranties

We make no warranties regarding uninterrupted access, accuracy of transaction data, or merchant acceptance. Cards are provided “as-is” without guarantees.
